**PROSPECTIVE MEMBERS** - Prospective members are welcome to participate in three local Group events before they are required to become a full member to ensure coverage by the Group's civil liability insurance. Some events may be unsuitable for pets or young families; always check with the event organiser first. Trips with an overnight stay are strictly limited to members-only so all participants are covered by the civil liability insurance. *Note: this is **NOT** a replacement for personal travel insurance which all members **must** obtain themselves before attending a Group trip.*

**JOINING THE GROUP** - At all times, our members are personally responsible for themselves and expected to respect the environment, local community, wildlife and other people. To keep our group safe, discrimination, prejudice, bullying or harassment of any kind is not acceptable or tolerated. Members are expected to behave respectfully across all the group's social media and maintain our family-friendly community. Please report any concerning behaviour in the group's online communities to our Member's Representative ([membersrep@ipswichoutdoor.org](mailto:membersrep@ipswichoutdoor.org)) as soon as possible.

The Group's membership year runs from 1 July to 30 June. If you join before 1 January 2020, your membership will be due for renewal on 30 June 2020. As an encouragement for prospective members, anyone joining the group for the first time after 1 January 2020, will have their membership extended so it will be due for renewal on 30 June 2021.

**MEMBERSHIP FEES** - Membership fees can be paid to the Membership Secretary ([membership@ipswichoutdoor.org](mailto:membership@ipswichoutdoor.org)) or Treasurer ([treasurer@ipswichoutdoor.org](mailto:treasurer@ipswichoutdoor.org)) by bank transfer, cash or a cheque made payable to **Ipswich Outdoor Group**. If making a bank transfer, please clearly include the sender in the reference, especially if transferring from The Co-operative Bank / Smile.

**MEMBERSHIP RENEWAL** - The Membership Secretary emails a reminder - in June. Members **must** return a completed membership form and fee for renewal by **31 July 2019** to ensure a personalised membership key tag for next year.

**CHILD MEMBERS** - Ipswich Outdoor Group members who are parents/guardians can apply for free child membership for children under the age of 18. Anyone over 18 must apply for their own Group membership. Please note when children, named on the front side of this form, participate in Group activities they must be accompanied by their parents/guardians and must be registered as child members. Members are responsible for their children *at all times* and should carefully consider the suitability of the activity for their child, after consultation with the event organiser.

**CONCESSIONARY MEMBERSHIP** - Concessionary membership is available to the unemployed (this does **NOT** extend to those who are retired), full-time students (member of a National Union of Students [NUS] affiliated students union or holder of an International Student Identity Card [ISIC]) or non-locals whose home postcode does **NOT** begin with IP (Ipswich), NR (Norwich), CO (Colchester), CB (Cambridge) or CM (Chelmsford) and may only attend a few events from the group programme. The Group reserves the right to request to see a valid student ID card or proof of home address.

Members' contact and emergency contact details is available to committee members and may be shared with other event organisers, in an emergency.
